Surita Sandosham is the President and CEO of Heifer International. Born and raised in Singapore. She has more than two decades of senior leadership experience at global nonprofit organizations. Most recently, she served as Executive Director of Heartland Alliance International, a humanitarian and human rights nonprofit based in Chicago, Illinois. Prior to Heartland, she was Vice President of Programs at the global nonprofit Synergos in New York, building multisectoral partnerships on behalf of smallholder farmers and other vulnerable populations.

Sandosham is a lawyer by training who graduated from City University London and the School of Oriental and African Studies at London University. As an international development practitioner and human rights advocate, she has served in leadership positions at Amnesty International, Equality Now, Rockefeller Foundation, Synergos, and Heartland Alliance International, working to accelerate agricultural growth, address malnutrition, improve retention rates in education and support economic development for marginalized communities.
