ELIGIBILITY REQUIREMENTS

Applicant is from an underrepresented population and background, which includes but is not limited to, American Indian or Alaskan Native, Asian, Black or African American, Native American or Other Pacific Islander, Hispanic or Latinx, and/or multiple of the aforementioned

racial identities, or who identifies as LGBTQ+; and/or demonstrates a defined commitment to issues of diversity and inclusion.

- Applicant is a United States citizen, or a permanent resident of the U.S. Applicant is currently attending an ABA-accredited law school within the U.S. and will be enrolled full-time in Fall 2025.
- Applicant can demonstrate strong academic achievements as reflected in transcripts from an ABA-accredited U.S. law school and from the recipient's undergraduate institution.
- Applicant is not a previous recipient of the USLAW NETWORK Foundation Law School Scholarship Program.

Contagious Illness Protocols
